**PARTIAL CANCELLATION FOR FEDERAL PERKINS STUDENT LOANS
FULL-TIME EMPLOYMENT FOR SERVICES AS LAW ENFORCEMENT OR CORRECTIONS
OFFICERS**

NOTE: Persons whose official responsibilities are supportive, such as those that involve typing, filing, accounting, office procedures, purchasing, stock control, food service, or building, equipment or grounds maintenance are not eligible for cancellation regardless of where these functions are performed.

1.) POSTPONEMENT - If you expect to be eligible for loan cancellation, you need to *complete a postponement form to stop all billing. A postponement will delay billing for the period you anticipate you will be eligible for cancellation (12 months at a time). Should you NOT be eligible for cancellation for any reason, all amounts accrued during the postponement period will become due and payable immediately.

2.) CANCELLATION - At the end of each year of employment you need to *complete a cancellation form to verify the completion of the year of full-time employment. Upon receipt of this verification cancellation will be processed as follows:

- 1st year 15% of original loan balance.
- 2nd year 15% of original loan balance.
- 3rd year 20% of original loan balance.
- 4th year 20% of original loan balance.
- 5th year 30% of original loan balance.

*The postponement/cancellation forms must be signed by your employer to be valid.
